**Complicating personality characteristic(s):**

- Uses humor to defuse serious situations – can be a strength or weakness dependent on situation
- Loyal, but with personal (not professional) trust issues
- Regularly self-deprecating and accepts blame (regardless of facts)
- Uses non-cover nicknames to psychologically unsettle partner (points to attention-seeking behavior)
- Uses humor/jokes and banter with team, especially partner (may be used as deflective self-protection reflex &/or overriding need for others’ acceptance... requires additional observation and analysis)
- Undisclosed (prior/current?) issue with being assigned a female partner (requires additional investigation)
- Focuses too much on partner’s jeans

**Issues to be addressed:**

- Traumatic, unsupportive childhood due to drunk/abusive father
- Shot father at age 11 (wounded, not killed); weapon acquired from Ray Martindale
- Ongoing feelings of insecurity (shallowly covered by over-inflated artificial ego)
- Unresolved personal (romantic) feelings toward partner
